

Essex Law Global Partner Scholarships 2024-25

If you're an international student studying at one of our Law global channel partners listed below, you could be eligible for a scholarship worth up to 20% of published international fees, which you'll receive as a tuition fee discount distributed across your years of study.

Terms and conditions

Eligibility

- These scholarships are restricted to students who are overseas fee payers and are entirely self-funded*.
- Students must be studying on the Law transfer programme in the link/partnership agreement at the specified institutions above.
- Students must register for the first year of a full-time undergraduate degree** at the University of Essex in October 2024-25.

- Applicants must meet our standard conditional offer.
- The award cannot be held in conjunction with any other University of Essex scholarships. Successful applicants should be available for promotional activities

Students who are not eligible

The following students are NOT eligible for this scholarship regardless of meeting the above criteria:

- Students undertaking a degree that is normally delivered wholly online.
- This scholarship award does not apply to deferred entry. Where a scholarship has been awarded to a student who subsequently defers entry to the following academic year, the award will be withdrawn and the applicant will be considered again in line with the terms and conditions that apply in the new proposed year of entry.
- Students who are fully or partly sponsored.
- Students who are assessed as Home fee payer.
- Current students whose first year of undergraduate study at the University of Essex, was prior to academic year 2024-25.

How to apply

If you meet all the eligibility criteria, you will automatically be considered for this award. You don't need to complete an application form. The University will assess your eligibility based on the academic transcripts and certificates that you submit with your application for your place at Essex.

Payment arrangements

- These scholarships will only be made available as a reduction on the tuition fee that is payable on registration at the University. Payment cannot be offset against a tuition fee deposit if one is required.
- If you intermit from your course, you may, at the discretion of the University, be entitled to a prorata payment of the remainder of your award on your return to study. Please contact the <u>Funding Team</u> for further information.

Resolution of disputes

Acceptance of this award constitutes acceptance of these terms and conditions. Applicants should contact the <u>Undergraduate Admissions Team</u> in the first instance for guidance regarding this award. Registered students should contact the <u>Funding Team</u>. In cases not covered by the above terms and conditions, or where a student claims exceptional circumstances, or disputes a decision not to make payments due under an award, final appeals on decisions regarding eligibility must be made via the
